# History and Evolution of the Rules and Regulations of the Cooperative Sector in Iran

- The Iranian economy is divided into three sectors: public, cooperative and private Which cooperative economy is second pillar of the Iranian national economy.
- The first cooperative society in Iran has established 1935 with the trend of agriculture in Garmsar city, followed by that a number of cooperative societies with the aim of distribution of public goods was established.





Establishment of the cooperative Agricultural Fund

#### 1955

Approval of the law of cooperative societies in the parliament and the approval of the rules of formation of the Supreme Council of Cooperatives in the supervisory board, the formation of a consumer cooperative for the use of the police personnel





#### 1925

Approval of the first regulations on cooperatives in the Commercial code



#### 1952

Approving the Statutes of the Bank for Development and Rural Cooperatives



#### 1963

Approving the Statute of the Central Organization for Rural Cooperatives



#### 1967

Establishment the Ministry of Cooperatives and Rural Affairs instead of the Ministry of Land Reform and Rural Cooperatives, Establishment the Organization for the Promotion and Development of Non-Agricultural Activities under the Ministry of Cooperatives

# The Potential of the Iranian Cooperative Sector



- The Iranian Co-operative movement has more than 80 years old.
- Co-operatives sector is a second pillar of the national economy of Iran in the constitution of the country
- more than 14 million membership in cooperative society
- activity of more than 92,000 active cooperative societies in the cooperative sector (50%Manufacturing, 28% services, 22% Distributing)
- activities of 55 national cooperative Unions, more than 640 Provincial Cooperatives Unions and more than 1100 Union of Cities and over 50 Export-based cooperatives

# 80 years

- dividing cooperative chambers across the country into 6 regions of the country, according to the climatic, environmental and ethnic conditions.
- forming 13th specialized Economic committees In Iran Chamber of Cooperatives, and provincial and cities chambers.
- Reception and dispatching trade and business delegations, holding training seminars, exhibitions and various fairs in different trends in international, country or provincial levels.
- membership of cooperative representatives in 28 committees, councils, working groups, commissions, headquarters and decision-making circles of the country





- The undisputed support of the Supreme Leader for cooperating and promoting the belief and cooperative approach in the country based on the constitution and development policies
- Membership of representatives of the cooperative sector of Iran in the decision-making circles and specialist policy-makers of the cooperative sector at the regional and global levels, including the International Union of Cooperatives
- Clustering and networking of cooperatives throughout the country, even in low-population and rural areas
- The possibility for public to enter and participate in the economic, social and cultural environment in the form of co-operative
- Integration of the approach and belief in co-operative with Iranian traditions and traditional attitudes from ancient times to today
- The inclusion of "safeguarding human values and the rights of members in cooperatives" as the main pillar of cooperative activity
- Interests and motivation of cooperators to interconnection, interaction and exchange with cooperative actors in different countries.



# Introduction to Iran Chamber of Cooperatives

Iran Chamber of Cooperatives as the highest level of non-governmental people-based organization of the cooperative movement in Iran will give all its efforts for an overwhelming qualitative and quantitative development of the cooperative sector activities in different fields. Iran Central Chamber of Cooperatives was established in 1992 it has 31 cooperative chambers in provincial centers and 5 chamber in cities and 55 cooperative alliances and more than 50 supranational cooperatives. Representatives of the Iran Chamber of Cooperatives attending high councils for decision-making and advisory services within the country and international associations play a significant role in the policy-making process with the approach of protecting the rights of co-operatives and pursuing their legal demands.

# Scope of Authorities and Activity of Iran Chamber of Cooperatives (ICC)

- Non-Governmental Representative of the Cooperative Division of Iran in the International Union of Cooperatives and all Associations, Councils, national and International Organizations.
- Issuance of a membership card and a business card for the cooperative sector activists.
- Establishing a higher education, technical and vocational training center in accordance with applicable laws and regulations.

- Providing cultural services and promoting cooperative education for members and strengthening the principles and values of co-operation and publishing books and publications required.
- Assist in the empowerment of cooperatives and their guidance in technical, legal, financial, administrative and commercial matters.
- Performing applied researches on the types of activities of different types of cooperatives.
- Provide advisory opinions to the government and parliament and other authorities on bills, drafts, drafts and sections related to affairs and activities of cooperatives.
- Participation in planning for the development of the cooperative sector in line with the economic development of the country.
- Establishment and administration of the Center for Economic and Economic Information in order to carry out the duties and activities of the Chamber.
- Establishing an arbitration center in accordance with the terms and conditions approved


